**YOUR AGREEMENT WITH CAPITAL AREA TRAVEL LEADERS**

Before we make arrangements for your flight, hotel, car rental, tour, cruise, or other trip, we require that you sign this form; your signature will signify your agreement with the following terms and conditions:

Cruise Network Plus, Inc. d/b/a Capital Area Travel Leaders. (“CATL”) acts as a sales agent for any airline, hotel, car-rental company, tour operator, cruise line, or other service provider named in your itinerary (“Suppliers”). CATL is not responsible for acts or omissions of the Suppliers or their failure to provide services or adhere to their own schedules.

CATL assumes no responsibility for and shall not be liable for any refund, personal injury, property damage, or other loss, accident, delay, inconvenience, or irregularity which may be caused by: (1) any defaults, wrongful or negligent acts, or omissions of the Suppliers; (2) any defect in or failure of any vehicle, craft, equipment, or instrumentality owned, operated, or otherwise used or provided by the Suppliers; or (3) any wrongful or negligent acts or omissions on the part of any other party not under CATL’s control. You hereby release CATL from all claims arising out of any problem covered in this paragraph.

You acknowledge and understand that cruise lines, tour operators, and other Suppliers have their own contracts covering cancellation penalties and other terms and conditions, and that you may be bound by those contracts regardless of whether you receive notice of their terms.

CATL has imposed a cancellation fee on your trip in the amount of \$650.00 per person once the deposit is made. This fee is in addition to the nonrefundable booking or service fee charged with your deposit. This cancellation fee is in addition to any cancellation penalty charged by any supplier.

CATL nor the driver of your vehicle is responsible for any accidents, injuries or damages to yourself or your belongings. The driver of your vehicle may not have nor is required to have a CDL (Commercial Driving License) for driving in Iceland.

CATL has no special knowledge regarding the financial condition of the Suppliers, unsafe conditions, health hazards, weather hazards, or climate extremes at locations to which you may travel. For information concerning possible dangers at destinations, CATL recommends contacting the Travel Warnings Section of the U.S. State Department at (202) 647-5225 or [www.travel.state.gov](http://www.travel.state.gov). For medical information, CATL recommends contacting the Centers for Disease Control at (877) FYI-TRIP or [www.cdc.gov/travel](http://www.cdc.gov/travel). You assume full and complete responsibility for checking and verifying any and all passport, visa, vaccination, or other entry requirements of your destination(s), and all conditions regarding health, safety, security, political stability, and labor or civil unrest at such destination(s). You hereby release CATL from all claims arising out of any problem covered in this paragraph, and to submit all other claims against us within 30 days after the return of your trip. You agree that the courts in {Eaton County, Michigan USA} will be the exclusive jurisdiction for all claims brought by you or CATL, and you hereby submit to the personal jurisdiction of those courts.

For your protection, CATL strongly recommend that you purchase trip cancellation insurance and that you check the appropriate box below. We also strongly recommend that you use a credit card for your purchase, so that you can exercise your rights under the Fair Credit Billing Act if you do not receive the services you purchased.
