(“CATL”) acts as a sales agent for any airline, hotel, car-rental company, tour operator, cruise line, or other service provider named in your itinerary (“Suppliers”). CATL is not responsible for acts or omissions of the Suppliers or their failure to provide services or adhere to their own schedules.

CATL assumes no responsibility for and shall not be liable for any refund, personal injury, property damage, or other loss, accident, delay, inconvenience, or irregularity which may be caused by: (1) any defaults, wrongful or negligent acts, or omissions of the Suppliers; (2) any defect in or failure of any vehicle, craft, equipment, or instrumentality owned, operated, or otherwise used or provided by the Suppliers; or (3) any wrongful or negligent acts or omissions on the part of any other party not under CATL’s control. You hereby release CATL from all claims arising out of any problem covered in this paragraph.

You acknowledge and understand that cruise lines, tour operators, and other Suppliers have their own contracts covering cancellation penalties and other terms and conditions, and that you may be bound by those contracts regardless of whether you receive notice of their terms.

You assume full and complete responsibility for checking and verifying any and all passport, visa, vaccination, or other entry requirements of your destination(s), and all conditions regarding health, safety, security, political stability, and labor or civil unrest at such destination(s). You hereby release CATL from all claims arising out of any problem covered in this paragraph, and to submit all other claims against us within 30 days after the return of your trip. You agree that the courts in {Eaton County, Michigan USA} will be the exclusive jurisdiction for all claims brought by you or CATL, and you hereby submit to the personal jurisdiction of those courts.

CATL assumes no responsibility for countries visa requirements or approval. The client is responsibility for required open passport pages, visa application accuracy, processing fees and sufficient timing for processing.

Pricing is based on the taxes, entrance fees, fuel surcharges and other considerations in effect when the tour price was set. In the event of a change outside of CATL’s control, CATL reserves the right to pass these costs on to the traveler.
